COMPETITORS: SPECIAL COVID-19 INFORMATION

Due to ongoing concerns with COVID-19, we are asking for your cooperation to limit the possible spread of the disease, and ensure the trial environment is safe and comfortable.

The CKC has instituted COVID specific guidelines that allow for temporary changes to Obedience and rally obedience Rules and Regulations. These are available on the CKC's website, www.ckc.ca. Please make sure you are familiar with them.

Please do not participate if you answer "Yes" to any of the following in the 14 days prior to the trial:

- Have you experienced any fever, cough, or difficulty breathing?
- Have you returned from the U.S. or other international destinations:
- Have you been contact traced to a COVID-19 case?
- Have you had contact with a compromised person who has been outside Canada?

Special Measures and Instructions:

- Face masks/face coverings will be required in the building and when entering and exiting the indoor ring. This requirement may be amended or waived depending on government and local health guidelines.
- Indoor shoes will be mandatory from the time you enter the building until the time you leave.
- Please park to allow for social distancing.
- There will be no indoor crating. Please crate from your vehicle while at the trial. Shade structures must be spaced to permit physical distancing.
- To facilitate social distancing, we ask that you do not bring friends, children, spouses, or others unless you need them to provide mobility assistance at the trial.
- A sign board will be available near the entrance to the building for exhibitors to indicate they are present and running in the class. **DO NOT TOUCH THE BOARD.** A steward will mark you as present and make any run order changes that are needed. A 2 m (6 ft) buffer will be marked around the gate steward.
- All briefings will be done outside the building.
- Only the current exhibitor and "on deck" dog may be in the facility at any given time.
- Walk-through group size will be limited to 5 exhibitors per walk-through, and competitors will be required to wear a mask.
- Exhibitors will remove and retrieve their own leashes. A chair or other object will be placed in the ring for the leash.
- Ribbons are not self-service; we will make every effort to have ribbons and scoresheets available as quickly as possible.
- We will have a team member cleaning all "touch" areas during the day. Equipment will be sanitized at the end of each day and if/when stewards are changed.
- The restroom will be the only facility available to exhibitors. Sanitize your hands before entering and exiting the washroom.
- Paper towels, soap, and hand sanitizer will be available throughout the facility.
- We encourage you to leave the facility promptly when you are down for the day.
- No lunch will be served.

CATALOGUES

Catalogues are available on a PRE-ORDER basis. Those who wish to pre-order at a price of \$3.00 may do so by indicating this on their entry form. There will be a limited number of catalogues available for sale at the trial for a price of \$5.00.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

USA EXHIBITORS

Bank drafts of money orders in Canadian Funds and personal cheques, payable in U.S. funds, and for the full amount of the entry, will be accepted. Personally discounted cheques will not be honoured. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par" as such items are not cleared through the banks.

BITCHES IN SEASON

Bitches in season are not permitted to compete. When a bitch comes into season after entries close, a Veterinarian's Certificate, certifying that the bitch was in season within ten days of the trial must reach the Trial Secretary on or before the day of the trial prior to the judging of the class and the club will refund entry fees.

ENTRY INFORMATION

1. No entry will be accepted unless all particulars called for on the entry form are completed in full.
2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
3. Alterations, substitutions, or cancellations of any entry after the closing date is prohibited. Only dogs which are already registered with the Canadian Kennel Club, or are eligible for registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
ENTRIES POSITIVELY CLOSE WEDNESDAY September 15, 2021, at 8:00 pm
4. Identification cards and judging schedules will be emailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the trial.
5. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any NSF cheques will be subject to a \$40.00 service charge.**

GENERAL INFORMATION

1. The Trial Superintendent will be in full charge of the trial which will be governed by CKC rules.
2. The North York Obedience Club Inc. will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability, in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
3. If, because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the trial, no refund of Entry will be made.
4. The trial precincts shall be considered to be 10 feet from all obedience ring sides.
5. Any ties in individual classes, or for High In trial, will be determined by the judge in accordance with rule 8.9, whereby the dog and handler will be re-tested individually.
6. Tie-breaking judge for the high score of the day shall be the judge who finishes last.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of, and will comply with, the CKC Obedience Trial Rules and Regulations.
